**DIRECT RECRUITMENT TO THE POST OF POLICE CONSTABLE IN
POLICE DEPARTMENT, U.T. OF PUDUCHERRY**

- Ref: 1) This department Notification No.2841/A1/Estt.I(B)/POL/2018 dated 20.08.2018.
- 2) This department Corrigendum Notification of even number dated 31.05.2019.
- 3) G.O.Ms No.5/2019/Wel.(SCW-II) dated 8/3/2019 of Adi Dravidar Welfare Secretariat, Puducherry
- 4) G.O.Ms.No.03/2019-20/Wel(SCW-II) dated 22.02.2020 of Adi Dravidar Welfare and Scheduled Tribes Welfare Secretariat, Puducherry.

In partial modification of the Notification dated 20.08.2018 and Corrigendum Notification dated 31.05.2019 under reference first and second cited above and as per G.O. notified by Adi Dravidar Welfare and Scheduled Tribes Welfare Secretariat, Puducherry vide reference third and fourth cited, 0.5% reservation is now being made to "Scheduled Tribes" Irular (including Villi and Vettaikaran) community and 0.5% reservation to "Backward Tribe (BT)" community out of the 1% reservation already earmarked to Backward Tribe.

Hence, applications are invited only from men and women who belong to "Scheduled Tribes" Irular (including Villi and Vettaikaran) community vide reference third and fourth cited above and covered under the upper age limit relaxation from above 24 years to 29 years as on 22.09.2018 for recruitment to the post of Police Constable, Police Department, U.T. of Puducherry as detailed below. All other conditions stipulated in the Notification dated 20.08.2018 and Corrigendum Notification dated 31.05.2019 shall remain unaltered.

****(Out of the total 3 posts earmarked to BT community in the recruitment to fill up 390 posts of Police Constable vide reference first and second cited above, two posts are now earmarked to 'Scheduled Tribes' Irular (including Villi and Vettaikaran) community and one post is now earmarked to 'BT' Community vide reference third & fourth cited.***

Note:-


- (i) Horizontal reservation for Meritorious Sports Persons will be ensured as per rule.
- (ii) 33% Horizontal reservation for Women in each category.
- (iii) There shall be horizontal reservation for Ex-Servicemen as per rule.
- (iv) Reservations and concessions in recruitment shall be extended as per rules in force.

1) The **crucial date** for determining the upper age limit shall be as on **22.09.2018**.

3) The list of already eligible candidates who had applied already under BT category in pursuance to Main Notification dated 20.08.2018 and Corrigendum Notification dated 31.05.2019 hosted in the Puducherry Police official website <https://police.py.gov.in>. now classified under Scheduled Tribes Irular (including Villi and Vettaikaran) community with retrospective effect from 22.12.2016 vide G.O. fourth cited above need not apply again and their applications may provisionally be considered under the respective 'Scheduled Tribes Irular (including Villi and Vettaikaran) community.

4) Candidates fulfilling the eligibility criteria may apply **only** through online in the above official website which will be available from 10:00 hours on 23.06.2020 to 22.07.2020 upto 23.50 hrs.
