In Pursuant to the Notification cited above, the provisionally selected candidates for the post of Male/Female warder in Jail Department, Puducherry are hereby instructed to appear for certificate verification, as per the schedule indicated against their names in the Annexure, **with the following original Certificates along with a set of self attested Photostat copies of the same:-**

- i. Certificate in proof of age (Birth Certificate / Board Certificate);
 - ii. Certificate in proof of Educational Qualification;
 - iii. Nativity / Residence Certificate (issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar. The certificate should have been issued within one year from the date of notification of results of this recruitment test);
 - iv. Community Certificate / Income certificate in case of EWS category candidates (obtained in the prescribed form issued by an officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar. The certificate should have been issued within one year from the date of notification of results of this recruitment test);
 - v. Original Discharge Certificate and the registration particulars with the Sainik Welfare Department, Puducherry in respect of Ex-servicemen candidates;
2. The candidates are advised to download Attestation forms for Verification of Character and Antecedents
 3. Filled in attestation form in **triplicate** shall be submitted to the Chief Superintendent of Jails, O/o the IG(Prisons), Chief Secretariat, Puducherry.
 4. No T.A will be paid for the certificate verification.
 5. In-service candidates should obtain the service certificate from the Head of Department / Office indicating his/her Name/Designation/Education Qualification/ Date of Initial Appointment with name of post/category to which he/she belongs to etc., in support of his/her claim.
 6. If he/she failed to appear for certificate verification on the date and time prescribed above, his/her provisional selection will be treated as cancelled.
 7. Offer of appointment will be issued only after verification of character and antecedents by the concerned authority.
