The Directorate of Survey and Land Records, Puducherry issued notification dated 12-12-2022 to fill up 12 vacancies in the post of Draughtsman as follows:

The common written competitive examination for recruitment to the posts of Field Surveyor and Draughtsman in the Directorate of Survey and Land Records, Puducherry was held on 03-12-2023.

The selection under MSP quota for the post of Draughtsman (1 No.) has been delinked by the Directorate of Survey and Land Records, Puducherry with the approval of the Competent Authority due to non finalization of the sports merit list. Accordingly, the vertical and horizontal reservation for the post of Draughtsman has been revised as follows:

As the syllabus for both the written competitive examination for Draughtsman and Field Surveyor was found to be the same a common written competitive examination was held on 03-12-2023. Before the examination, all the candidates who had applied for both the posts of Draughtsman and Field Surveyor were requested to exercise their option indicating their preference of the post and accordingly the candidates exercised their option.

Based on the marks obtained in the competitive examination held on 03-12-2023, the category wise provisional select list and wait list is drawn as given in the **Annexure-I & II**, respectively.


The select list / wait list has been drawn taking into the account the option exercised by the candidates who have applied for both the posts of Draughtsman and Field Surveyor. In respect of candidates who have applied for only one post their candidature is considered against the post applied for. Wherever first choice of the candidate who have applied for both the posts could not be considered based on their merit they have been considered for their second choice and they are also placed in the wait list of the post for which they have given first choice.

In respect of EWS category no candidate has scored the minimum qualifying marks and hence the post earmarked for EWS has been utilised by Unreserved category as per extant rules.

In respect of Ex-Servicemen category no candidate has scored the minimum qualifying marks prescribed in the recruitment notification.

The provisional selection is subject to verification of original certificates of educational qualification, age, nativity / residence, category and community certificates issued by Competent Authorities. The schedule for certificate verification will be intimated by the Directorate of Survey and Land Records, Puducherry.


